The New Parking System in Brno

Advantages of the Parking System

From September 1, 2018

the new parking system will apply in the inner centre of Brno.

From November 1, 2018

it will be in place in three more areas.

For residents

Parking will improve in the area where they live.

For subscribers

The long-term parking of vehicles will be regulated, and the turnover will improve, as well the chance to park.

For visitors

Opportunities for short-term parking will improve.

Brno was inspired by the well-tested parking systems of other world metropolises and chose the “flower” system as the most favourable for residents. The parking authorisation of the resident and of the subscriber will be valid not only in the area of their permanent residence or place of business (establishment), but also in the immediate neighbourhood. This will greatly enlarge the area where they can park without added charge. The only exception is the inner centre of the city, where only people living there will be able to park.



Who the system applies to

I am a resident

- Natural person with permanent residence in the defined area.
- Private individual owning property in the restricted area.
- In an area where I have residence rights, (I live there or in the immediate neighbourhood), I can park where there is a vertical road traffic sign with a blue stripe. Everywhere else I am a visitor.

What I need to arrange parking authorisation:

- Proof of permanent residence or ownership of property (ID document or excerpt from the Cadastre of Real Estate).
- Proof of legal relationship to vehicle (e.g. registration certificate).
- Payment of fee for parking authorisation.

I am a subscriber

- A legal entity or private individual in business with a head office in the restricted area.
- A legal entity or private individual in business which has a workplace in the restricted area.
- In areas where I have parking authorisation for subscriber, (I have a headoffice or place of business there or in the immediate neighbourhood), I can park where there is a vertical road traffic sign with a green stripe. Everywhere else I am a visitor.

What I need to arrange parking authorisation:

- Proof of the existence of a head office or workplace (extract from the commercial register).
- Proof of legal relationship to vehicle (e.g. registration certificate).
- Payment of fee for parking authorisation.

I am a visitor

If I am visiting a specific resident:

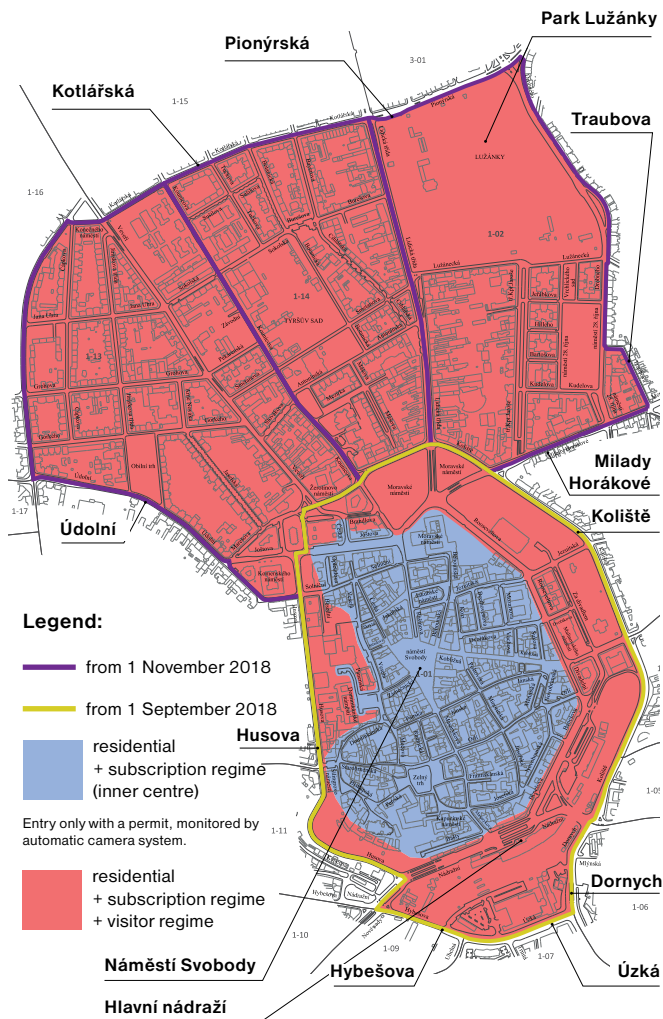
- Each resident, regardless of their age or whether they own a car, can provide their visitors with up to 150 hours of authorised parking annually.
- Parking authorisation can be provided via the personal page of the user (resident).

I need to arrange something in the centre:

- In places where on the vertical traffic sign there is an orange stripe I can now park for 30 minutes for free.
- Parking for longer is paid (payment in parking meter or through an online mobile app.).
- I can also park in P+R parking and in multi-storey car parks.



Map of System Areas



Visitors must arrange an entry permit for the inner centre of Brno. Residents and subscribers will get this automatically together with their parking authorisation.

I am a resident

All regulated parking spaces are marked with a blue stripe.

Visitor authorisation

The allocation of pricing zones is set by the city district according to the need to regulate parking.

Price zone for visitor regime	Free parking period	Price per hour
 Zone 1	30 min	40 CZK
 Zone 2	30 min	20 CZK

Parking authorisation for residents

	Price per year
1st car	600 CZK
2nd car	15 000 CZK
Each further car	30 000 CZK

Parking authorisation for subscribers

	Price per year
1st car	6 000 CZK
2nd car	20 000 CZK
Each further car	20 000 CZK

The new parking system brings a range of advantages. The aim is to allow more people to park and arrange important matters.

It makes sense to introduce restrictions where residents have a problem with parking, or where there is too much traffic during the day.

On most of the territory of Brno, where the new system of parking will be introduced in the future, the regulation will be applied only during the night hours. But the most critical areas will be regulated also during the day.



Information for Foreigners

A. Proving of permanent residence or the ownership of real estate in the Residential Area

- **Proving of permanent residence**
 - Persons that are not citizens of the Czech Republic (foreigners) and are also citizens of the European Union
 - travel document and
 - one of the following documents:
 - permanent residence card
 - certificate for the temporary residence of foreigners in the Czech Republic
- **Proving of permanent residence**
 - Persons that are not citizens of the Czech Republic (foreigners) and are also not citizens of the European Union:
 - travel document and
 - residence permit card issued for foreigners with permanent residence for the Czech Republic
- **Proving of ownership rights to real estate
in the Residential Area**
 - citizenship card or travel document and
 - extract from the Cadastre of Real Estate proving that the claimant owns real estate in the Residential Area.

B. Proving of legal relationship to the vehicle (vehicles)

- **Owner or operator of the vehicle**

With the vehicle registration document or the vehicle registration certificate.
- **User of a vehicle based on leasing or long-term rental**

With the vehicle registration document or the vehicle registration certificate, with the lease or rental contract, the certificate of business authorisation of the lessor in the field of leasing and lending of movable property.



Information for Foreigners

- **User of a vehicle based on a contract with a credit provider when buying a vehicle on a loan**

With the vehicle registration document or the vehicle registration certificate, loan contract and (if necessary) a related contract, from which it follows that the claimant has the right to use the vehicle, the certificate of business authorisation for the credit provider in the field of providing loans.

- **User of a vehicle based on the entrusting of the vehicle by the employer for the personal use of the claimant**

With the vehicle registration document or the vehicle registration certificate, an affidavit from the employer concerning the existence of a labour-law relationship between the employer and the claimant as an employee and concerning the entrusting of the vehicle to the claimant.

- **User of a vehicle based on the entrusting of the vehicle as a member of an elected authority of a legal entity (without an employment contract)**

With the vehicle registration document or the vehicle registration certificate, the affidavit by the legal entity proving that the claimant is a member of an elected authority of this legal entity, provided the legal entity is registered in the public register kept in accordance with the rule of law of the Czech Republic, with an extract from the public register proving the existence of this legal entity, respectively another document proving the existence of this legal entity.

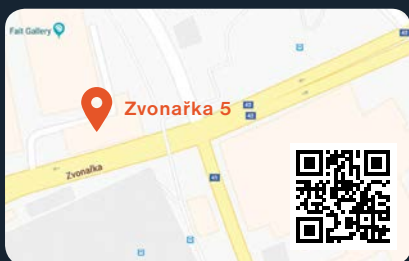
C. The payment of the price agreed for the parking of the vehicle according to the Pricelist
